The conference was well attended and feedback was very positive. Invited speakers included several individuals directly involved in research projects in Florida and throughout the nation and representatives from educational institutions involved in current policy decisions and implementation. Morgan C. Wang, Professor of Statistics and the Director of the Data Mining Program at the University of Central Florida, gave a pre-conference presentation focusing on the difference between traditional statistical inference and data mining. Several cases studies on college level educational data and the potential use of using data mining techniques to K-12 data were presented. The opening session for the conference began with Mark Reckase, Michigan State University, and Craig Wells, University of Massachusetts, highlighting current research trends on scaling, linking, and equating of large scale assessments and the challenges of scaling tests with various item types measuring complex constructs. An afternoon general session featured Vince Verges, FLDOE Assistant Deputy Commissioner, Division of Accountability, Research and Measurement, sharing information on the status of Common Core Summative Assessments in the state of Florida. Another afternoon general session features Mirka Koro-Ljungberg, University of Florida, and Jennifer R. Wolgemuth, University of South Florida, held an interactive workshop on methodology of qualitative research. The Thursday morning general session featured Kathy Hebda, FLDOE Chief of Staff, and Eric Larsen, AIR, talking about the history of the Value-Added Model in use in the state of Florida. The Thursday afternoon session features Todd Clark, FLDOE Director, updated audience on the progress of Race to the Top Assessments. Another Thursday afternoon general session was delivered by Michael Hynes, University of Central Florida, and Carrie Straub, University of Central Florida, introducing a simulated classroom, TeachLivE, and presenting about integrated video coding software that can be used for education research. For the Friday morning general session, Walter Leite, University of Florida, described methods to combine propensity score matching with multilevel modeling to reduce selection bias in estimates of the effects of non-randomly assigned treatments in longitudinal studies. Congratulations to our Distinguished Paper Award Winners, Anne Corinnne Huggins and Randall D. Penfield for their award winning paper entitled Relationship between DIF Location and Conditional Equating Dependence Issues.

As your graduate student representatives, we would like to invite you to submit a proposal for a poster presentation by **September 1st** to **fera.student.proposal@gmail.com.** The due date for posters is later than the deadline for papers and symposia in order to provide graduate students some extra time to prepare their submissions. **Graduate students are not limited to the poster session**, but the later date for posters has been specifically chosen to allow graduate students and faculty to circulate this call for posters to other graduate students at the beginning of the Fall Semester. Please forward this call to any graduate students that you know who may be interested in this opportunity to present at FERA.
